THE RAPID EVOLUTION OF ANTIBIOTIC RESISTANCE CAN BE ATTRIBUTED TO BOTH NATURAL SELECTION AND HUMAN INTERVENTION. KEY HISTORICAL EVENTS, SUCH AS WORLD WAR II, SAW AN ACCELERATED PRODUCTION AND USE OF ANTIBIOTICS, LEADING TO INCREASED EXPOSURE AND SELECTIVE PRESSURE ON BACTERIAL POPULATIONS.

MECHANISMS OF ANTIBIOTIC RESISTANCE

HORIZONTAL GENE TRANSFER

BACTERIA CAN ALSO ACQUIRE RESISTANCE GENES FROM OTHER BACTERIA THROUGH A PROCESS KNOWN AS HORIZONTAL GENE TRANSFER. THIS CAN OCCUR VIA THREE MAIN MECHANISMS:

- **TRANSFORMATION:** UPTAKE OF FREE-FLOATING DNA FROM THE ENVIRONMENT.
- **TRANSDUCTION:** TRANSFER OF DNA FROM ONE BACTERIUM TO ANOTHER VIA BACTERIOPHAGES.
- **CONJUGATION:** DIRECT TRANSFER OF DNA THROUGH CELL-TO-CELL CONTACT.

THIS ABILITY TO SHARE RESISTANCE GENES ACCELERATES THE SPREAD OF ANTIBIOTIC RESISTANCE AMONG BACTERIAL POPULATIONS.

FACTORS CONTRIBUTING TO ANTIBIOTIC RESISTANCE

SEVERAL FACTORS CONTRIBUTE TO THE DEVELOPMENT AND SPREAD OF ANTIBIOTIC RESISTANCE, MAKING IT A COMPLEX AND MULTIFACETED ISSUE.

OVERUSE AND MISUSE OF ANTIBIOTICS

LACK OF NEW ANTIBIOTICS

DESPITE THE URGENT NEED FOR NEW ANTIBIOTICS, THERE HAS BEEN A SIGNIFICANT DECLINE IN ANTIBIOTIC DISCOVERY OVER THE PAST FEW DECADES. THIS STAGNATION CAN BE ATTRIBUTED TO VARIOUS FACTORS, INCLUDING HIGH RESEARCH COSTS, REGULATORY CHALLENGES, AND LIMITED FINANCIAL INCENTIVES FOR PHARMACEUTICAL COMPANIES.

IMPACT OF ANTIBIOTIC RESISTANCE ON HEALTHCARE
