- **CONSTRUCTIVE INTERFERENCE:** OCCURS WHEN THE PEAKS OF TWO WAVES ALIGN, RESULTING IN INCREASED AMPLITUDE.
- **DESTRUCTIVE INTERFERENCE:** OCCURS WHEN THE PEAK OF ONE WAVE ALIGNS WITH THE TROUGH OF ANOTHER, RESULTING IN DECREASED AMPLITUDE OR CANCELLATION.

THIS EXPERIMENT NOT ONLY DEMONSTRATES THE WAVE NATURE OF LIGHT BUT ALSO PROVIDES INSIGHT INTO FUNDAMENTAL CONCEPTS IN PHYSICS, SUCH AS WAVELENGTH, FREQUENCY, AND THE SPEED OF LIGHT. THE MATHEMATICAL FORMULATION OF THE INTERFERENCE PATTERN CAN BE DERIVED FROM THE PRINCIPLES OF WAVE MECHANICS, MAKING THIS EXPERIMENT A CORNERSTONE OF BOTH CLASSICAL AND MODERN PHYSICS.

## QUESTION 3: WHAT ROLE DOES THE DISTANCE BETWEEN THE SLITS PLAY IN THE INTERFERENCE PATTERN?

ANSWER: THE DISTANCE BETWEEN THE SLITS INFLUENCES THE SHARPNESS AND SPACING OF THE INTERFERENCE PATTERN. CLOSER SLITS LEAD TO A MORE PRONOUNCED PATTERN, WHILE WIDER SLITS MAY CAUSE THE FRINGES TO BECOME LESS DISTINCT.

## QUESTION 4: DESCRIBE HOW YOU WOULD SET UP YOUNG'S EXPERIMENT IN A CLASSROOM.
